In its long-standing, hallmark, evidence-based Community-Based Mentoring Program, BBBSL recruits and matches children with caring adult mentors in one-on-one mentoring relationships. Professional staff enroll, train, and provide case management for all volunteers, children, and their families. These relationships are created with a goal to provide children with the emotional and social support, attention, and guidance necessary to support strong scholastic achievement, healthy peer-to peer/family relationships, avoidance of risky behaviors, and strong self-concept. Among children served, ages range from seven (7) through high school graduation.

Further, children served will often live in poverty; be from homes without two parents; be at elevated risk for involvement with the juvenile justice system; be youth of color, including African-American and Hispanic youth; be youth in a foster program; have an incarcerated parent; have a parent in the military; be from rural communities; or have a disability. Many of these youth will also have experienced adverse childhood experiences including, but not limited to physical and/or sexual abuse; physical and/or emotional neglect; domestic violence; substance abuse within the household; household mental illness; parental separation or divorce.

EVEN facing such significant system obstacles, ALL the Littles BBBSL serves are chock full of potential, talent, and resilience and deserve the opportunity to chase down their BIGGEST dreams. We say "YES" to hopeful parents and guardians who see incredible potential in their child, and we commit to finding a safe and caring adult mentor/Big willing to stand in their mentee's/Little's corner and have their back.

As such, BBBSL's model is designed to help youth gain protective factors that help prevent and build resiliency against additional childhood adversity and to help children imagine healthy, happy, and

productive futures. To ensure effectiveness, BBB SL measures and tracks the social, emotional, and academic progress made by each Little using an evidence-based youth and child outcome surveys at regular intervals. Staff compares pre-and post-survey results to assess child improvement in key areas. Professional staff use outcome data 1) to help inform coaching provided to mentors and parents/guardians to support future improvement and 2) to improve overall case management support provided to parents and mentors. Outcomes surveys measure changes in parental trust, social acceptance and peer relations, scholastic improvement; educational expectations; exposure to risk behaviors and more. Over time, all such factors correlate with improved school attendance, classroom behavior, grades, and graduation; improved mental health and self-esteem; avoidance of substance abuse and crime.

Also acknowledging that longer, stronger relationships result in the most positive outcomes for children, BBB SL conducts a strength of relationship assessment designed to evaluate the strength of mentor-child relationships with a goal of increasing match retention. Staff review all outcomes assessments and conduct continuous quality improvement in BBB SL's service delivery and to inform coaching provided to mentors and parents/guardians. Further, staff adapts child case plans to address persistent concerns or meet new emerging needs. Thanks to this rigor, BBB SL's average match community-based length after 12-months in the program is greater than 40 months.

Parents/guardians wishing for their child to receive one-to-one mentoring refer their child into the BBB SL's program. Following referral, BBB SL interviews both the child and the parent/guardian to identify whether the child and family would benefit from and be able to support a child-adult mentoring relationship. Additionally, the interview seeks to understand each child's social/behavioral/academic goals/needs, each child's interests/preferences, and the parent's/guardian's preferences for the mentoring relationship. Should BBB SL deem itself able to secure a volunteer mentor for the child, it will enroll the child into the program. BBB SL does not charge families to participate in the program.

Volunteers who are interested in becoming a Big Brother or Big Sister must also go through an assessment/enrollment process which includes a comprehensive interview, criminal and driving background checks; reference checks, orientation, as well as initial, and when necessary, ongoing training to include, but not be limited to, child safety, trauma, cultural humility/JEDI, etc. Child safety is at the heart of the program, so before being matched, volunteers are screened both to determine safety whether they will be appropriate/psychologically safe mentors. Further, the mentor's interview will seek to determine the mentor's preferences, interests, and unique experiences that could prove beneficial for the mentoring relationship. BBB SL requests that volunteers cover the costs of their background checks (\$30). When matching a child with an adult mentor, staff carefully consider all factors (interests, experience, geography, etc.) to make the best match possible.

Before a match is made, BBB SL proposes the child first to the mentor. If the child agrees, BBB SL then proposes the mentor to the family. While the parent/caregiver has the power to veto the mentor, the child

has final say even if the parent/caregiver approves.

Once a match is made, the adult mentors provide their Little Brother or Little Sister with individualized attention two to four times each month (four to eight hours total) for at least one year. During regular, unstructured outings, mentoring pairs have the freedom to choose the activities they will enjoy and from which the child will benefit most. With parent/guardian approval, these activities can take place wherever they decide in the local community as the mentoring pair builds a strong, lasting friendship. BBB SL provides suggestions about a range of low-cost or free activities to participate in and around the local area and invites matches to monthly agency-hosted activities. During time with their mentors, children expand their experiences beyond their families or neighborhoods, gain new skills, explore new interests, and talk with an adult they trust one-on-one. Further, BBB SL provides bi-monthly coaching videos to mentors, ongoing resources during coaching calls, and ongoing training. When families are in need to additional support, BBB SL provides referrals to other local providers.

To ensure the mentoring relationship is progressing safely, that children are benefiting measurably from their mentoring relationship, that mentors are receiving the support they need to stay committed, and that there is consistent communication between everyone involved, BBB SL requires monthly (first 12 months) or quarterly (following 12 months) support phone calls for the life of the mentoring relationship (with the scheduled determined by match duration or level of support needed). Match support calls take place 1) between the staff and the mentor, 2) between the staff and the parent/guardian, and 3) between the staff and the child. Additionally, mentors and families are encouraged to reach out to staff anytime they feel they need additional support or referrals to other community partners. Further, each child has their own youth outcome development plan that is reviewed regularly and updated annually with all three parties so that the child is receiving they need to grow in their personally identified need/growth areas.

The compensation of the Organization's officers and key employees is reviewed and considered by the Board of Directors as part of the annual budgetary process.
